2. To create and implement a mechanism to handle the reported grievances.
3. To forward the findings to the Management if necessary for further action.
4. To listen, record and scrutinize the grievances submitted to them by the staff and students and take necessary steps immediately.
5. To represent the grievances to the concerned section in which may include maintenance, academic, amenities etc.
6. To convene periodical meeting to discuss whether the grievances have been settled.
7. To make a follow-up of these matters at regular intervals till their final disposal.
8. To maintain strict confidentiality if necessary

System of the Committee or Procedure for lodging complaint

1. The students may feel free to put up a grievance in writing or in the format available in the admin department and drop it in boxes.
2. The grievance cell will act upon those cases which have been forwarded along with the necessary documents.
3. The grievance cell will assure that the grievance has been properly solved in the grievance has been properly solved in a stipulated time limit provided by the cell.
4. Students can register their complaints through written in prescribed.

The antisexual harassment cell of Angami College has arranged a meeting with the members of the Student Union of Angami College at the conference hall.

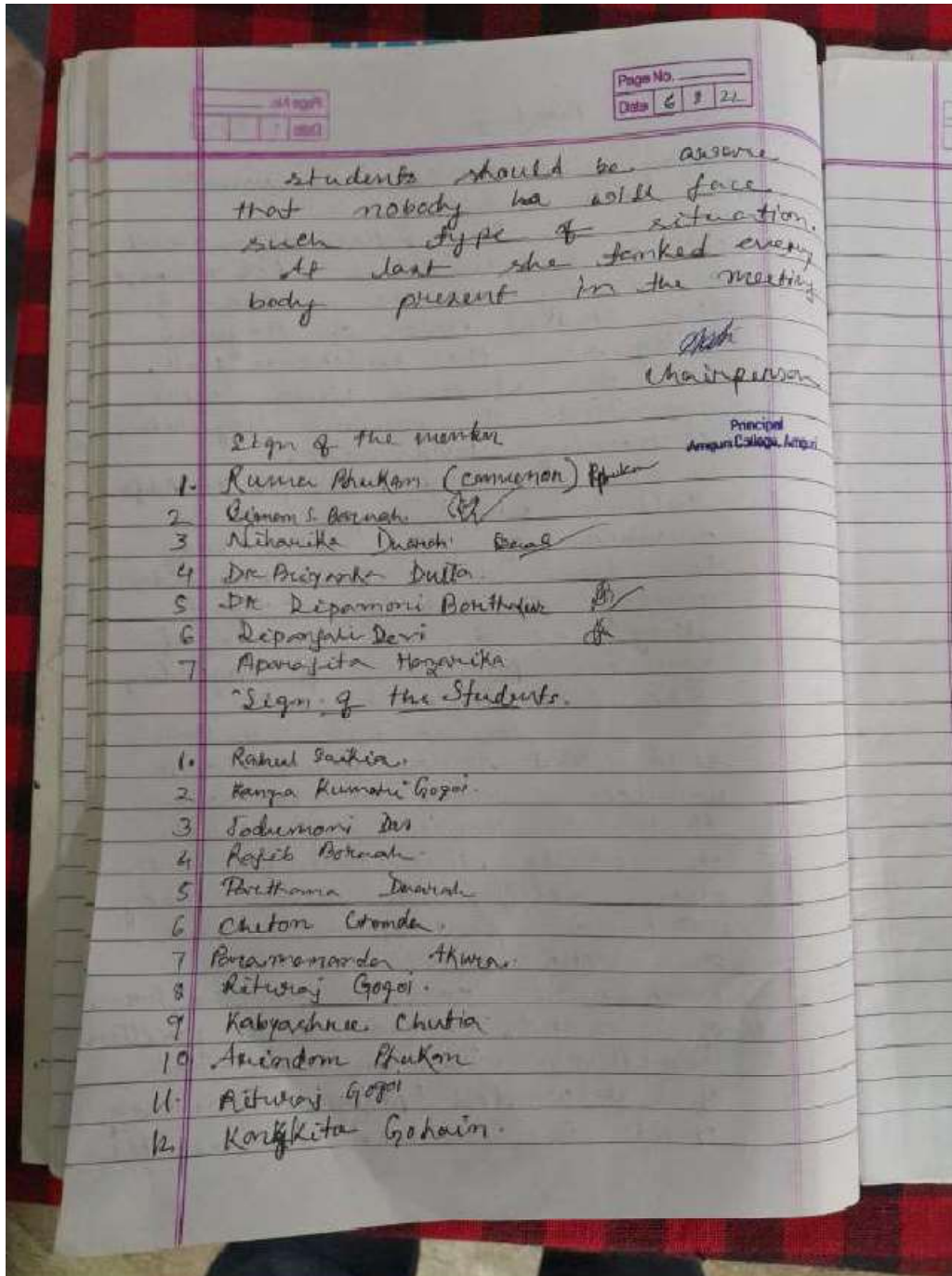
The students Union were appraised of various regulations concerning harassment.

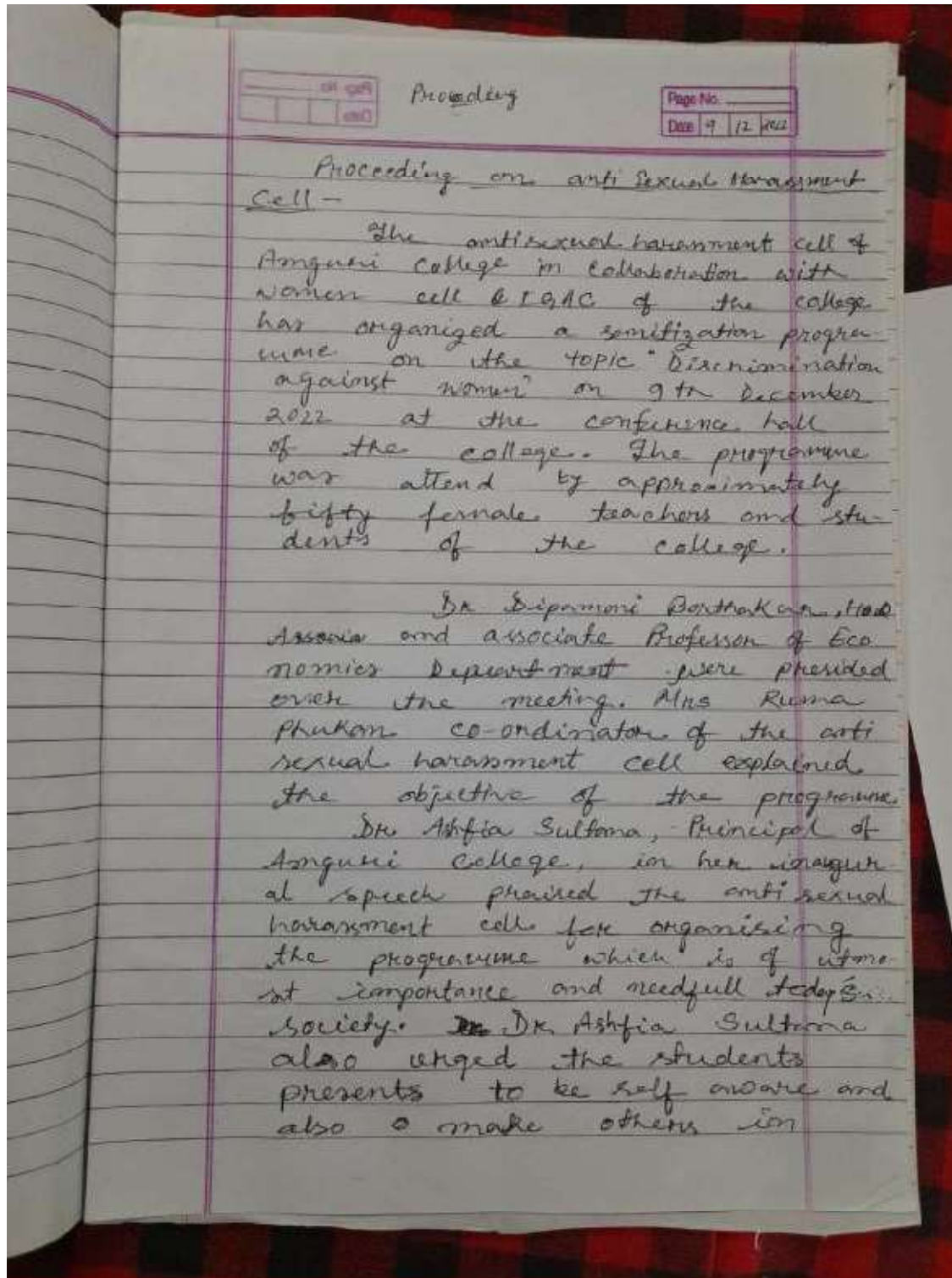

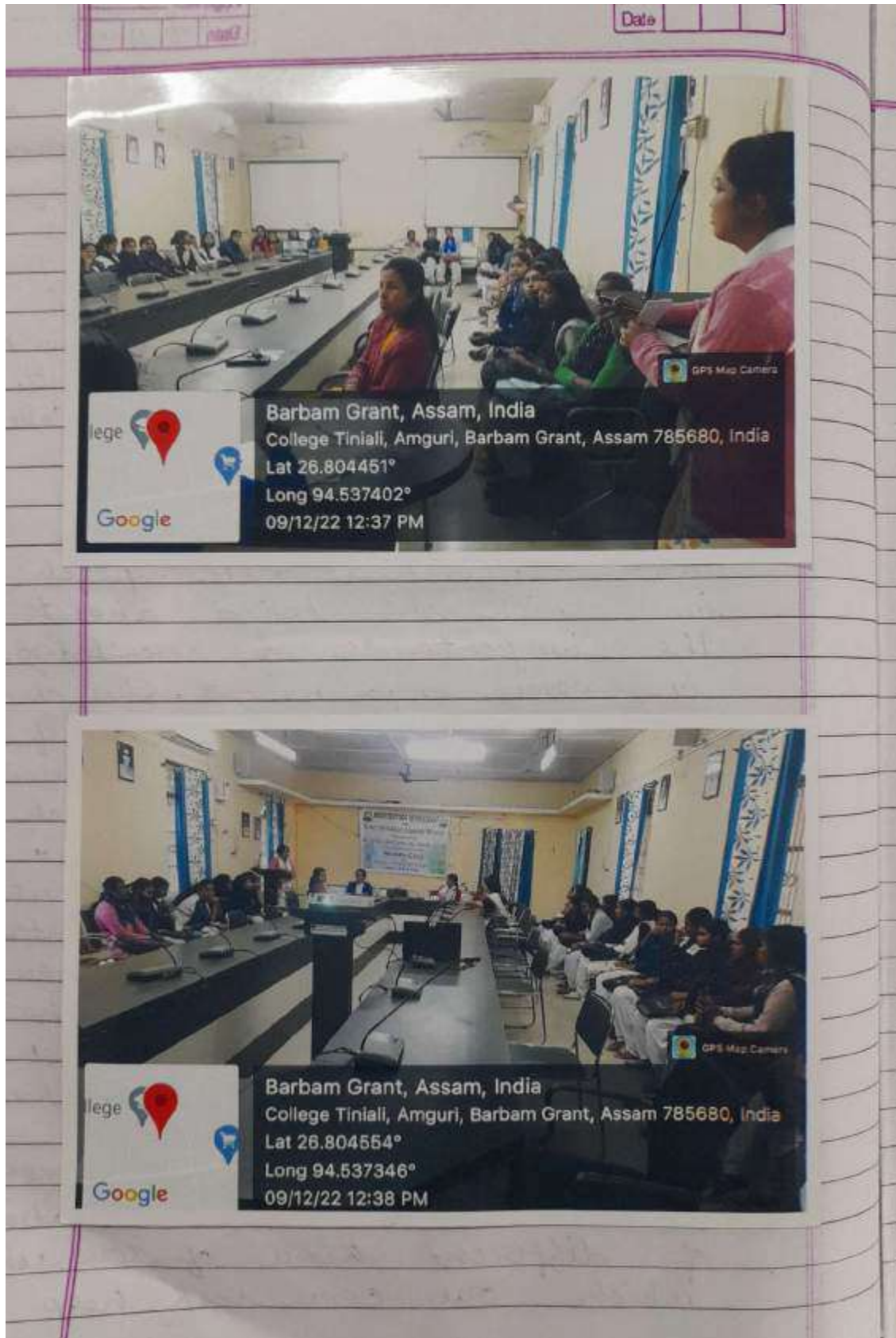


their family and locality in the context of sexual harassment.
